Taggers with >50mm lenses will be designated as Sniper Rifles/Marksman for the whole duration. BFS Scorpion taggers will be designated as SMGs for the whole duration. All other taggers will be set to emulate the weapon they were created as e.g. M16, M4, AK47, SAW, etc). **Only one primary tagger and one secondary weapon per player .**

### **1.1 The participant consents and agrees with the following rules, terms and conditions:**

The participant agrees to abide by the rules of Logan Laser Skirmish at all times when present at the Laser Skirmish venue

- (a) No projectiles are to be thrown, kicked or otherwise made airborne by participants.
- (b) No participant shall engage in:
  - \* Skylarking or Reckless Behavior or Foolish behavior: or
  - \* any other behavior likely to cause injury to themselves or other participants: or employees or agents or Logan Laser Skirmish
  - \* Any other behavior which Logan Laser Skirmish deems in its absolute discretion to be unacceptable
- (c) Logan Laser Skirmish may require any participant engaging in unacceptable behavior to leave the Laser Skirmish Venue.
- (d) Each participant must remain in the designated boundaries of the Laser Skirmish venue.
- (e) Each Participant will be required to wear the following:
  - \* Long Trousers and Enclosed Shoes: and
  - \* Hats and/or Helmets provided by Logan Laser Skirmish:
  - \* All other safety devices that Logan Laser Skirmish may require the participant to wear
- (f) Any participants who are unable or refuse to comply with rule (e) will not be permitted to participate.
